The required documents will be sent by e-mail (pdf format) and the originals by post to the Erasmus Office address.

RO BRASOV01 will send to the partner institution the acceptance letter within maximum 4 weeks from the reception of the required documents, according to the information provided at <http://www.unitbv.ro/orien/InternationalStudents/ErasmusStudents/Incoming.aspx>.

3. A Transcript of Records will be issued by the receiving institution no later than [5] weeks after the assessment period has finished at the receiving HEI. *[It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]*

Transcript of Records will be issued by **RO BRASOV01** no later than 4 weeks after the assessment period has finished, and sent by post to home institution.

4. Termination of the agreement
