4. Termination of the agreement

*In Romania, marks are given on a scale of 1 to 10, with 5 meaning that "performance meets the minimum criteria required in order to pass", 10 meaning „outstanding performance“, and 1 to 4 meaning „failed“. For Erasmus students, the scores are grouped in 7 categories, each corresponding to a general qualitative appreciation: 10 – A, 9 – B, 7-8 – C, 6 – D, 5 – E, 4 – FX, 1-3 – F.*
