3. A Transcript of Records will be Issued by the receiving Institution no later than 5 weeks after the assessment period has finished at the receiving HEI.
4. Termination of the Agreement or changes in the data set above should be made by written notification before **September 1st** for the following academic year. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.

[In the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1.
