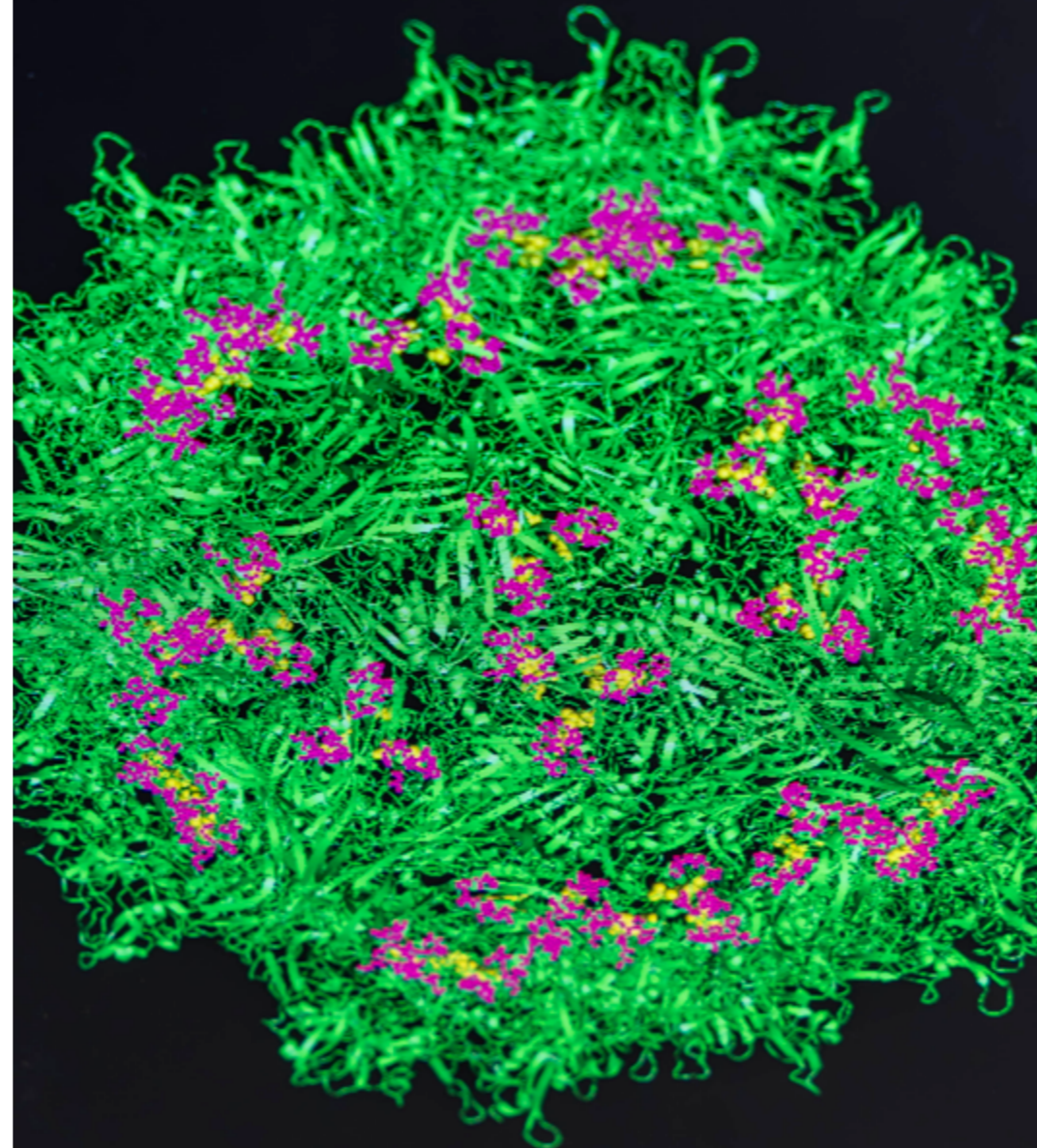

# HEALTH & WELLNESS

As a contract researcher, you have access to **Portugal's Public National Health Service (SNS)**.

You can register at a local health center to access public health-care.



## Social Security and ADSE

Employment contracts provide coverage for illness, parental leave, and retirement.

## Private Insurance

You may opt for supplementary private insurance or check your eligibility for ADSE (public servants' scheme) via HR.

### IMPORTANT

If you are here on a research grant, **Social Security is not automatic.**

# 02 UNDERSTAND

*Your contract, rights and benefits.*

This section gives you a clear overview of how employment works in Portugal and what you can expect when joining NOVA FCT.

Here you'll find essential information about your contract, your legal rights as an employee or grant holder, and the benefits and protections available to you while working in Portugal.

# EMPLOYMENT IN PORTUGAL

Employment in Portugal is regulated and contract-based.

All research-related positions require a written contract that defines your role, duration, salary, working hours, and probation period.

If your position requires a PhD, official degree recognition in Portugal must be completed before signing the contract.

## Contract Types at NOVA FCT

NOVA FCT uses several types of contracts depending on the project and funding:

### Fixed-term contract

Linked to project duration; the most common format.

### Researcher contracts

under the national Research Career framework.

### Open-ended contract

Used for long-term or permanent positions.

### Research fellowships

Not employment contracts - include fewer labour rights.

## Probation Period

The probation period is the initial phase of an employment contract during which both parties assess whether they wish to maintain the employment relationship. It may be waived by written agreement between the parties.

In academia, probation periods vary according to the contract type. For instance, for a junior researcher with a 12-month fixed-term contract, the probation period may be up to 30 days, whereas for an Assistant Researcher on a permanent contract, it may extend to five years.



## IMPORTANT

Your employer is always **NOVA FCT** or **NOVA.ID**, not the **research unit** where you work.

## Salary & Benefits

Employment contracts in Portugal typically include 14 payments per year. While research grants are exempt from tax, employment contracts are subject to Social Security (~11%) and IRS income tax.

## Working Hours & Leave

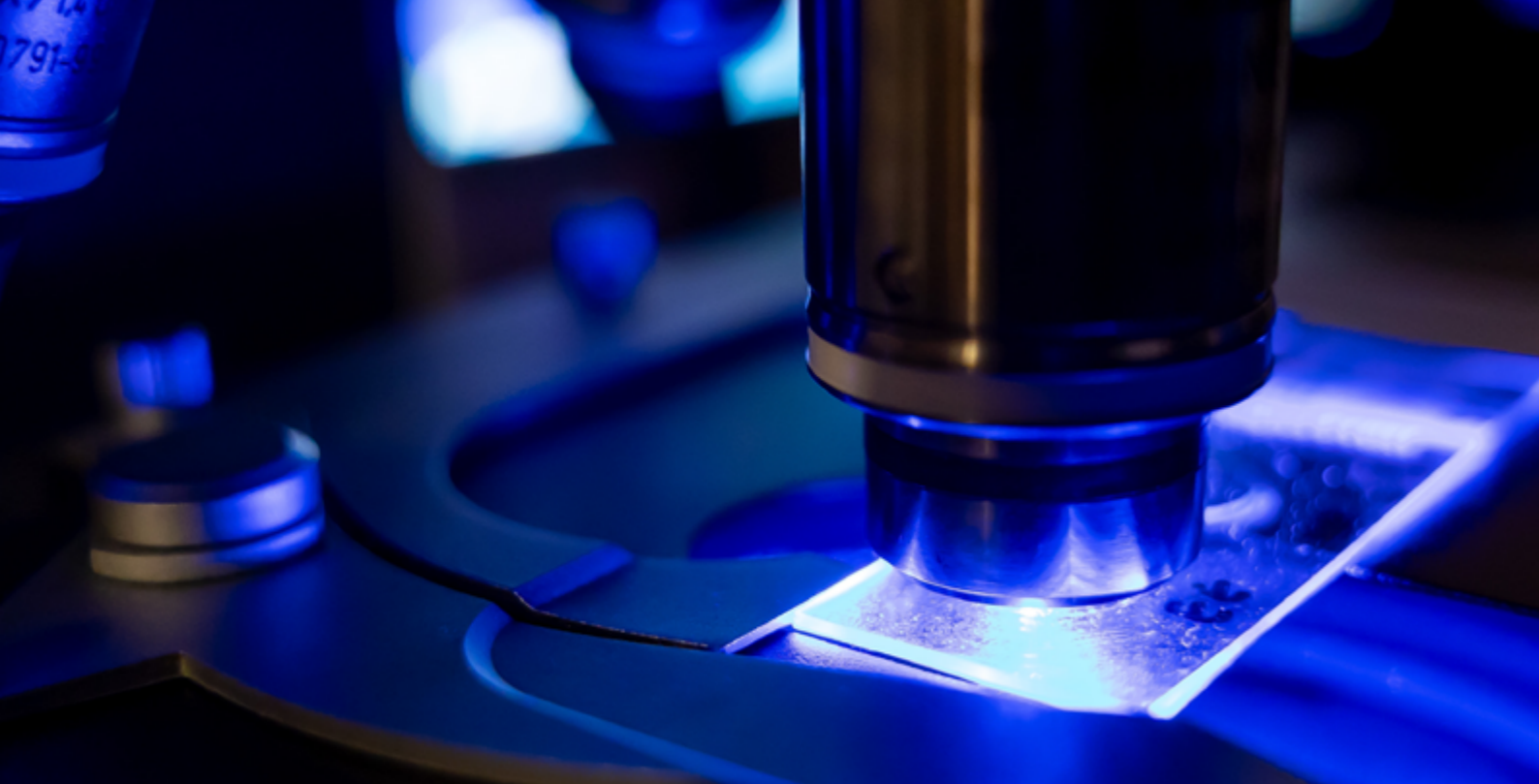
**Standard Hours:** 35 hours per week (7 hours per day).

**Weekly Rest:** Two rest days per week.

**Annual Leave:** 22 working days of paid vacation per year.

**Short Contracts:** If your contract is under one year, leave is proportional (2 days per month).





## Contract Termination

Understanding how and why a contract ends is just as important as signing it. Under Portuguese labour law, an employment agreement may conclude due to:

**Expiration:** The agreed duration of your contract comes to an end.

**Resignation:** You choose to leave the position voluntarily..

**Mutual Agreement:** Both you and the university agree to part ways amicably.

**Justified Dismissal:** In specific legal cases, such as job extinction or unsuitability.

## IMPORTANT

If you are on a fixed-term contract and it expires due to the university's decision not to renew it, you are legally entitled to financial compensation.



# IFICI

## Tax Incentive for Non-Resident Researchers

Portugal has created the Incentive Scheme for Scientific Research and Innovation (IFICI), a special tax regime designed for non-resident researchers and PhD holders who move to Portugal to carry out research activities. This regime offers favourable tax conditions, making Portugal more attractive for international talent in science and innovation.

For detailed information on eligibility criteria, procedures, and benefits, the Portuguese Chartered Accountants Association (OCC) provides a practical and updated guide. The HR Division will also assist you in assessing your eligibility, contact them as early as possible.

# 03 SETTLE IN

*You've been selected, what's next?*

This section guides you through the essential steps to get established in Portugal after accepting your position at NOVA FCT.

# BEFORE YOUR ARRIVAL

Once you receive your formal offer, your priority is handling legal documentation.

These processes can take weeks or even months, so **start as soon as possible**.

## 1. PhD DEGREE RECOGNITION

If your PhD was awarded by a foreign institution, **it must** be officially recognized in Portugal before you can sign your contract.

### Where to Apply

Use the Direção-Geral do Ensino Superior (DGES) Portal.

### Automatic Recognition

For degrees from institutions with pre-approved agreements (e.g., EU). Cost: ~€27

### Level Recognition

Confirms your degree matches a Portuguese PhD level. Cost: ~€55–€138

### Specific Recognition

A detailed academic evaluation for non-standard cases. Cost: ~€426.

### IMPORTANT

**DO NOT DELAY THE PhD RECOGNITION PROCESS.**

Without it, the university cannot legally finalize your employment contract.

## 2. NIF (TAX IDENTIFICATION NUMBER)

The NIF is essential for signing your contract, opening a bank account, and renting a home. You can often obtain a provisional NIF before arrival if you have a fiscal representative in Portugal.

### What It Is

The Portuguese tax identification number required for all major administrative and contractual procedures.

### Why You Need It Early

Your employment contract, housing arrangements, and banking setup all depend on having a valid NIF.

### Option 1: Obtain It From Abroad

You can request a NIF before arriving in Portugal through a fiscal representative who submits the application on your behalf.

### Option 2: Obtain It In Person

If you prefer, you can request your NIF after arrival at a Finanças office or Citizen's Shop (Loja do Cidadão).

### Fiscal Representative Requirement

Mandatory only for non-residents. Once you have Portuguese residency, the representative is no longer needed.

### Documents Required

Passport and a simple proof of address (your home-country address is accepted for remote applications).

### Cost

Typically free when issued directly by the Portuguese Tax Authority.

### Processing Time

Usually immediate for in-person requests and very fast when submitted by a representative.

## 3. RESIDENCE PERMIT (NON-EU CITIZENS)

NOVA FCT collaborates with AIMA (Agency for Integration, Migration and Asylum) to **fast-track applications for highly qualified researchers**.

Contact HR as soon as you accept your offer to start this institutional submission.

### Who Needs It

All non-EU researchers must obtain a Portuguese residence permit to legally live and work in Portugal.

### Fast-Track Through NOVA FCT

The university collaborates directly with AIMA to accelerate residence permit applications for highly qualified.

### Start the Process Early

Contact the HR Division as soon as you accept your offer so they can initiate the institutional submission on your behalf.

### What AIMA Handles

AIMA processes visa appointments, residence permits, and legal stay authorizations for non-EU nationals.

### Documents You Will Need

Passport, employment contract or hosting agreement, proof of accommodation, and valid health insurance (exact list provided by HR).

### Documents Required

Passport and a simple proof of address (your home-country address is accepted for remote applications).

### After Arrival in Portugal

You must attend your scheduled AIMA appointment to provide biometrics and finalize your residence permit.

### Processing Time

Timelines vary, but institutional submissions are significantly faster than individual applications.

# AFTER YOUR ARRIVAL

Once you arrive in Portugal, there are a few essential steps to complete before fully settling into your research activities at NOVA FCT.

These procedures ensure that your institutional access, legal documentation, and practical arrangements are all in place, allowing you to start your work smoothly and confidently.



## 1. REGISTRATION AT NOVA FCT

Your first stop at NOVA FCT is the HR Division, where your onboarding officially begins. This registration unlocks your campus access, institutional email, and the essential tools you'll need for your daily work.

### Why It Matters

This step activates your institutional access and completes your onboarding.

### What You Receive

Your institutional ID card, campus access permissions, and official email account.

### Where to Go

Human Resources Division (HR) on campus.

### Institutional ID Card

Issued during your registration, this card gives you access to campus buildings, library services, and other essential facilities.

### Institutional Email Activation

Your official NOVA FCT email is created at this stage. It's your primary channel for academic, administrative, and research communication.

### Campus Access Setup

HR activates your permissions so you can use buildings, labs, and shared spaces across the campus.

## 2. OPENING A PORTUGUESE BANK ACCOUNT

Setting up a local bank account ensures you can receive your salary or research grant smoothly. It also makes everyday life easier, from paying rent to managing monthly expenses.

### Why You Need It

A Portuguese bank account is required for salary or grant payments and for most long-term financial arrangements.

### Documents Required

Banks typically ask for your passport, NIF, proof of address, and proof of employment or your HR onboarding confirmation.

### How to Open It

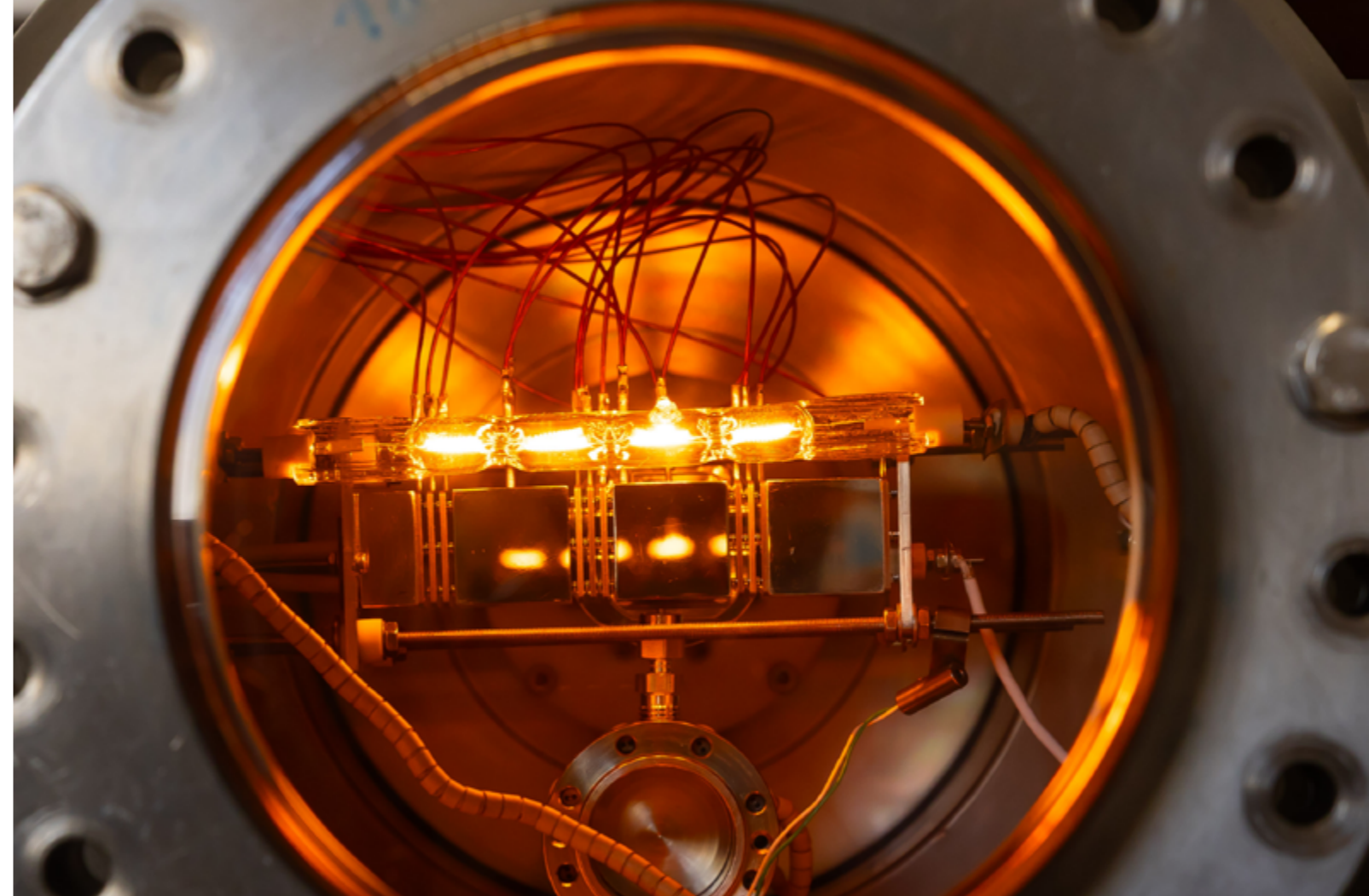
You can visit a bank branch in person, and some banks allow you to book an appointment in advance to reduce waiting times.

### What to Expect

Account activation is usually quick, but some banks may take a few days to finalize verification.

### Tip for a Smooth Start

If your account takes time to open, digital banks like Revolut or N26 can help you manage daily expenses in the meantime.



## 3. SOCIAL SECURITY REGISTRATION

Your social security status ensures you're covered while working or researching in Portugal.

Depending on your contract type, this step may be handled for you or require your action.

### For Employment Contracts

HR registers you automatically with the Portuguese Social Security system.

### For Grant Holders

You must enroll in the Voluntary Social Security Scheme yourself, as this is not handled by the institution.

### Why It Matters

Social security registration provides access to social protection, including healthcare coverage and other benefits.



## 4. AIMA APPOINTMENT (NON-EU CITIZENS)

Your AIMA appointment is an important milestone in finalizing your legal stay in Portugal. It's where your biometrics are collected and your residence permit moves into its final stage.

### ● Purpose of the Appointment

AIMA verifies your documents and collects biometric data required for issuing your residence permit.

### ● What You Need to Bring

Passport, proof of accommodation, employment contract or hosting agreement, and any documents indicated by HR.

### ● Why It's Important

Attending the appointment on the scheduled date avoids delays in receiving your residence permit.

## 5. SECURING LONG-TERM ACCOMMODATION

Once your initial documents are in place, you'll be ready to settle into a long-term home. This step helps you establish stability and fully transition into your life in Portugal.

### ● Why This Step Comes Now

With your NIF and bank account ready, you can legally sign rental contracts and complete housing formalities.

### ● What Landlords May Request

Proof of employment, deposit payments, and sometimes a guarantor or additional documentation.

### ● Tip for a Smooth Process

Start your search early, as the rental market can be competitive in the Lisbon region.
